# Street Liaison Report

July 1, 2017 to June 30, 2018

The Street Liaison program delivers essential services to the business community within targeted commercial corridors found in their respective quadrants by providing access to information to support business growth, attracting new businesses and supporting economic development in neighborhood business corridors.

Neighborhood Service Centers contracted with Action for a Better Community, Highland Planning, and  $19^{TH}$  Ward Community Organization to deliver Street Liaison Services in each of the four quadrants of the City for a total amount of \$80,000.

In 2017-2018 fiscal year, contract totals were \$20,000.

Program changes made in 2018-2019 year. In an effort to make all the contracts equitable, the northwest and southeast were added one commercial corridor each for a total of 4 commercials corridors per contract.
