#### **Environmental**



## **Neighborhood Improvement & Housing**

- Like to see more homeownership
- More help for homeowner occupants for fixing up their homes- for those who are not very poor, but the working class
- More beautification of streets (ie trees, lights)
- Neighborworks low interest loans require you to borrow more money than you need and then the interest costs more and loses some of its value
- Homesteading Program targeting vacant homes
- Need to improve building facades on South Plymouth—make it more of a welcome feel.

#### **Transportation**

- Exchange Street does not handle the volume of traffic that is currently on it. Very narrow for the volume. Currently, need to improve street function and keep on-street parking.
- South Plymouth need to attract through traffic.
- Need a corridor plan for South Plymouth—needs attention and focus.
- Engage with UofR to provide more transportation to campus from rentals in area
- Pedestrian access across river—Flint Street Area
- Water Access at end of Flint with parking (Canoe/kayak)
- Zip line on slopes and cross country trails
