The Contractor must submit this Subcontractor/Supplier Payment Certification Form with each invoice after invoice #1. The form certifies that subcontractors and suppliers who performed work have been paid in full for all undisputed work and deliveries included in each prior payment application submitted to and paid for by the City of Rochester contract.
