



Enhanced STAR Exemption Renewal

Dear Enhanced STAR Applicant:

This is the Enhanced STAR renewal application. Annual renewal of Enhanced STAR exemptions is required by State of New York law. We encourage you to **mail** in your application with documentation to avoid the long lines.

PLEASE READ ALL DIRECTIONS AND QUESTIONS CAREFULLY. Include a copy of page 1 from your **2013** Federal or New York State Income tax returns if you file a return. If you do not file tax returns, you must submit all **2013** income statements to verify income. To qualify for the Enhanced STAR exemption, the **2013** Federal Adjusted Gross Income minus taxable IRA distributions for all owner(s) and spouse(s) must be **\$83,300.00** or less. If your income exceeds that amount you will still be eligible to obtain the Basic STAR exemption if you sign, date and return the application. **Please mark the application with "Income exceeds the limit". This will indicate to us that you continue to reside on the property.**

You should have already received the **2013** year end statements and tax return which you need to file with your renewal application. Your completed STAR renewal application **should** be returned as soon as possible to avoid processing delays. **The application must be returned no later than February 2, 2015.** You will receive a written notice from this Bureau if you qualify, or not qualify, for the Enhanced STAR exemption.

Starting in **2015**, you may authorize this Bureau to transmit your Social Security number(s) to the New York State Department of Taxation and Finance (DTF) for verification of reported income. If you choose this option and the DTF qualifies your income, you will no longer be required to submit paper documentation to this Bureau. You must continue to reside on the property to qualify for the exemption. Please indicate your preference in this area on the application. Even if you choose this option, you must submit the paperwork requested this year. You will not receive a renewal notice in **2015.**
