Jalapeno Eating Contest

Lakeside Winterfest, February 11, 2017, 2 pm

Real heat for a cold day!!

Be the 1st champ.

\$10 participation fee

Must be 18 years old

Signed release and \$10 entry fee must be received by Friday, February 3rd!!!! Participation limited to the first 20 entrants

1st prize- \$100 cash and Wegmans gift card

2nd prize- \$50 cash and Wegmans gift card

3rd prize- \$25 cash

Rules:

-5 minute timed contest

-Each contestant will receive a plate with 10 whole, pickled jalapeno peppers and one small cup of water. There will be additional plates of 10 whole peppers on the table for eating after the first 10 are consumed. Each contestant must eat only one pepper during the first minute. Each contestant then must eat as many peppers as they can during the next 4 minutes, one pepper at a time consuming the entire pepper excluding the stem. After time is called, contestants must then wait an additional two minutes before having anything additional to eat or drink. Judges will count the stems during this period.

-Peppers must be eaten down to 1/8 inch from the stem to be counted.

-Any contestant unable to keep the peppers in their stomachs for the entire two minute waiting period will be disqualified.

-Winner will be determined by the number of stems on the contestant's plate after time has been called. Contestants will be allowed to finish any peppers in their mouths when time is called.

-If there is a tie, an additional serving of peppers will be available.

Release of liability;

In consideration of my participation in the Jalapeno eating contest at the Lakeside Winterfest, I hereby accept all risk to my health and of my injury and death that may result from such participation and I hereby release the Ontario Beach Program Committee, the City of Rochester and the County of Monroe as well as all their employees, officers or representatives from any liability to me , my personal representatives, estate, heirs, next of kin and assigns for any and all claims and causes of action for loss of or damage to my property and any and all illness to my person including my death that may result or occur during my participation in the Lakeside Winterfest Jalapeno eating contest, whether caused by negligence of the Ontario Beach Park Program Committee, the City of Rochester, the County of Monroe , their officers , employees, representatives or otherwise.
