**City Council** 

In our last newsletter we shared with you our council priorities. These six areas of focus will be where we spend the bulk of our time and attention this session. They are: Deficit reduction and long term financial sustainability; Creating and sustaining a culture of vibrancy; Public safety; Rebuilding and strengthening neighborhood housing; Jobs and economic development; and Support the creation of effective education systems.

In addition, we also have come to consensus on prioritizing some non-legislative actions; we want to find ways to make City Hall more accessible, to engage city residents, and to hear your voices and opinions. I believe this effort will strengthen our neighborhoods and build more resilient communities.

One way we are engaging residents is by finding ways to have more people involved in our boards and commissions (<u>http://www.cityofrochester.gov/boardsandcommissions</u>). Our boards and commissions are ways of engaging neighbors to have a positive and direct effect on the quality of life and economic vitality of Rochester.

Recently we have worked to create alternate positions for some of our boards. Three individuals will be selected as alternates who will be able to step in to hear cases where standing members are absent or must recuse themselves from the case that will be heard. The boards that will expand their membership to include alternates are: the Zoning Board of Appeals, the City Planning Commission, and the Rochester Preservation Board. These positions will allow residents to be involved in the important decisions that shape our City.

Page three of this newsletter will go into more detail concerning the requirements for these membership on these boards. There are spaces available for alternate members on all boards, and some permanent ones as well. If you have any interest in serving your community on a board, please contact the Council Office.

## WANT TO JOIN A CITY BOARD? What you need to know.

City Planning Commission

The City Planning Commission is a seven member citizen commission that has jurisdiction and authority in the issuance of Special Permits, subdivision approvals, and a wide range of other matters. This board also makes recommendations to City Council regarding Zoning Text and Map amendments.

The Planning Commission holds a monthly public hearing, held one Monday evening a month at 6:30pm in City Hall, and staff support is provided by the Bureau of Planning and Zoning.

Any person residing in the City may apply to be a member of this board. As of April, there is one alternate vacancy. Rochester Preservation Board

This seven member citizen board reviews applications for Certificates of Appropriateness required for alterations to landmarks and properties located in the City's eight preservation districts. It is also responsible for developing and adopting preservation guidelines.

The Rochester Preservation board holds a monthly public hearing held one Wednesday evening a month at 6:00pm in City Hall, and staff support is provided by the Bureau of Planning and Zoning.

Requirements for membership include: real estate professional, membership in a historical association, residency in a preservation district, and status as a registered architect. As of April, there are three alternate vacancies on this board. Zoning Board of Appeals

The Zoning Board of Appeals is a seven member citizen board that hears requests for Variances to the City's Zoning Code, and Administrative Appeals of decisions made by the Manager of Zoning.

The Zoning Board of Appeals holds a monthly public hearing held one Thursday morning a month at 9:30am in City Hall, and staff support is provided by the Bureau of Planning and Zoning.

Any person residing in the City may apply to be a member of this board. As of April, there is one permanent vacancy in the Northwest and three alternate vacancies on this board.

On Friday, March 20th Councilman Adam McFadden and the City of Rochester hosted the United Negro College Fund (UNCF) College Fair, for the first time in over a decade. The event was focused on juniors and seniors and was a partnership with school districts to provide this unique experience to area students. Hundreds of young people attended this event. The College Fair was one of a series of three events that took place that day. In conjunction with the College Fair, Mayor Warren hosted The Mayor's Luncheon with Dr. Michael Lomax, President and CEO of the UNCF. This event raised money for scholarship opportunities for students in the area. And the final event was a Town Hall Meeting with Historically Black Colleges and Universities (HBCU) at East High School in the evening. All events were resoundingly successful, and Councilman McFadden hopes to make this an annual event.








The City of Rochester is committed to ensuring the rights of all its citizens. That's why last year we expanded our non-discrimination clause to protect all people regardless of gender identity or expression. This is not enough, we need New York State to enact these same policies. Our State Assembly has passed GENDA seven times, City Council is calling on the State Senate to approve GENDA. **GENDA** is the Gender Expression Non-Discrimination Act. It is a bill that would outlaw discrimination based on Gender Identity or Gender Expression in New York State.

The City of Rochester has created an online petition which will be submitted to the New York State Legislature. We are demanding that the State Assembly pass GENDA again and that the State Senate PASS GENDA NOW!


