### **RULES AND REGULATIONS:**

- A. Your location(s) must be left clean and free of litter and debris at the end of the rodeo.
- B. All items are will be confined within the boundary lines to prevent injuries and to facilitate foot traffic.
- C. On the day of the event, locations will be assigned based on availability through the Market Office after 3:30 p.m. Food Trucks will have preference in placing. Vendors that show up after 4:00 p.m. may not be placed with no refunds. All Vendors must check in at the office. "No Parking" along the handicap area...the waiting area is the front parking lot off N. Union St.
- D. Vendors must use the location(s) assigned to them. Sharing location(s) will not be permitted.
- E. Vendors are prohibited from hawking, shouting, using music, etc., to attract customers.
- F. New Vendors must provide a photo of what they are vending from. (Example: Truck, Cart or Trailer. We will not be accepting rolling carts, tables or counters. You must at least have a Food Cart).

FAILURE TO OBEY THE ABOVE RULES AND REGULATIONS MAY RESULT IN TERMINATION OF YOUR PARTICIPATION AT THE MARKET.
