A Draft Generic Environmental Impact Statement (DGEIS) has been completed and accepted for the proposed action described below. The DGEIS provides an in-depth report on the Vacuum Oil Brownfield Opportunity Area (BOA) Plan and the range of potential impacts and alternatives related to the implementation of the Plan. Name of Action: Vacuum Oil Brownfield Opportunity Area (BOA) Implementation Strategy

Type of Action: Type I

Description of Action: The neighborhood’s vision for the Vacuum Oil BOA is analyzed and alternatives explored in order to take the plan from a conceptual plan to a more detailed and developable plan with information and tools to advance development. The analysis includes many component studies, including: Housing Analysis and Reinvestment Strategies; Geotechnical Investigations; Floodplain Engineering Assessment & Mitigation Studies; Wetlands Impacts & Mitigation Studies; Traffic Study; Transportation and Infrastructure Feasibility and Enhancement Studies; Building Condition and Structural Assessments; and Waterfront and Public Realm Concept Plans.
