Property Attributes	Year Built	Assessment System	The year the structure was built
Property Attributes	Building Size	Assessment System	Square Footage
Property Attributes	Land Size	Assessment System	Parcel size
Property Attributes	Owner Occupied	Assessment System	Properties are flagged when mailing address matched property address or the owner receives the Star Exemption
Property Attributes	Current Use	Assessment System	This is where you can separate out residential from commercial uses, as well as other uses, classified by the NYS Use Code System
Property Attributes	City Owned	Assessment System	
Property Attributes	Last Sale Date	Assessment System	
Property Attributes	Owner Location	Assessment System	
Property Attributes	Assessed Value	Assessment System	
Property Attributes	Property Type	Assessment System	Two Types - Land or Structure
Vacancy	Vacant Date	BIS	You can use this to assess how long properties have been vacant
Vacancy	Occupancy Status	Building Information System (BIS)	Two Types – Occupied or Vacant
Permits	Business Permits	BIS	Properties with open Business Permits, including permit type
Code Enforcement	Open Case	BIS	This will tell you whether or not Code Enforcement has an open case on the property
Code Enforcement	Open Case – Fines Owed	BIS	Properties that have outstanding code fines (tickets issued)
Code Enforcement	Open Case – Violation Count	BIS	This will tell you how many outstanding code violations there are on a property
Code Enforcement	Demo Case	BIS	This will tell you which properties are currently listed as demolition cases
Code Enforcement	Permit Case	BIS	This will tell you whether or not there is an open Building, Plumbing or Electrical Permit Case
Code Enforcement	Code Compliant Rental	BIS	Properties that have a current C of O and no outstanding code violations
Code Enforcement	Code Compliant Rental Expiration	BIS	C of O expiration date
Code Enforcement	Work Order Charges	Munis	Outstanding work order fees (refuse removal, grass cutting, board-ups, demo)
Police & Fire	Police Incidents	RPD	This will tell you how many and what types of Police Incidents may have occurred at the location, based on RPD Crime Reports

Utilities	Water Bill	Water Bureau	Details water usage activity
Sales	Home Sales		Based on recorded deeds from all valid real estate transactions
Foreclosures	Tax Foreclosure	Treasury System	This will, tell you whether or not the property was initially included in the current year's tax foreclosure process
Foreclosures	Lis Pendens: Mortgage Foreclosure	Monroe County Clerks Records	This will tell you whether or not a mortgage foreclosure action has been initiated by a lender
Demographics	Census Data	Tolemi	Several census related data sets, pulled from the Decennial Census and the American Community Survey
Other	Active Nuisance Points – Exceeds Thresholds	BIS	This will tell you if a property has exceeded the threshold of 12 points in 6 months or 18 in a year
Other	Active Nuisance Points	BIS	Total number of points issued
Overlay	Various Data Sets	Various sources	There are several filtering options in this category to add to a more focused area search
