# **RED** means not eligible for Waiver **10 Points:**

- Article 265 of the Penal Law Firearms and Other Dangerous Weapons.
- Section 47-5 of the City Code Firearms, shotguns, rifles and other dangerous weapons

#### 6 to 10 Points:

- Article 220 of the Penal Law Controlled Substances Offenses. (Note that <u>sale</u> offenses are 10 points in new law, all other violations of this article are 6 points)
- Article 221 of the Penal Law Offenses Involving Marihuana. (Note that <u>sale</u> offenses are 10 points in new law, all other violations of this article are 6 points)

#### 6 Points:

- Article 225 of the Penal Law Gambling Offenses.
- Article 230 of the Penal Law Prostitution Offenses.
- Sections 165.15(4), (6), (7), and (8), 165.40, 165.45, 165.50, 165.52, 165.54, 165.71, 165.72, and 165.73 of the Penal Law Criminal Possession of Stolen Property.
- The Alcoholic Beverage Control Law.
- Sections 260.20 and 260.21 of the Penal Law Unlawfully Dealing with a Child.
- Possession, use, sale or offer for sale of any alcoholic beverage in violation of Article 18 of the Tax Law, or of any cigarette or tobacco products in violation or Article 20 of the Tax Law.

- Article 178 of the Penal Law Criminal Diversion of Prescription Medications and Prescriptions.

## **NUISANCE POINTS**

### October 30, 2018

#### Waiver of Nuisance Points.

- Eligibility:
  - To be eligible for a waiver of nuisance points, no nuisance points shall have been assessed against a property during the preceding twelve months.
  - A property is eligible for the waiver of nuisance points no more than one time in any twelve-month period.
  - Points resulting from the following violations are not eligible for waiver:
    - Article 265 of the Penal Law Firearms and Other Dangerous Weapons.
    - (b) Section 47-5 of the Code of the City of Rochester Firearms, shotguns, rifles and other dangerous weapons.
    - Sections of the New York State Uniform Fire Prevention and Building Code and Chapter 54 of the Code of the City of Rochester concerning occupancy requirements.
    - Sections 260.20 and 260.21 of the Penal Law Unlawfully Dealing with a Child
