PUBLIC INFORMATION MEETING MINUTES

Orange Street (Saxton Street to West Broad Street) & Saxton Street (Jay Street to West Broad Street) Rehabilitation City of Rochester Project No. 16125
September 28, 2021

The following is a summary of the above referenced project Public Information Meeting held on September 28, 2021 between 5:30 p.m. and 6:30 p.m. via Zoom Video Conference.

The Public Information Meeting (Zoom Video Conference) began with the introduction of the project through a slide presentation (available on the City Project website) followed by a live question / answer period afterward. There were (3) attendees from the public who joined the meeting.

Highlights discussed during the presentation are:

General Project Description:

- Mill and resurface pavement along Orange Street and Saxton Street.
- New stone curb will be replaced within the project limits (Orange Street and Saxton Street).
- New driveway aprons, driveway apron removals on some properties within the project limits (Orange Street and Saxton Street). Properties with driveway removal will receive notification letters from Permit and Zoning departments with instructions to follow to legalize their driveways.
- Driveway material policy discussion: existing surface vs proposed surface.
- New Carriage walks and Removal of carriage walks to properties within the project limits (Orange Street and Saxton Street). Property Owner who request a new carriage walk needs to pay for the installation.
- New fiber optic conduit within the project limits (Orange Street and Saxton Street).
- Spot concrete sidewalk replacement within the project limits (Orange Street and Saxton Street).
- New accessible curb ramps within the project limits (Orange Street and Saxton Street);
- Street lighting improvements: Davit arms and LED fixtures will be added to new and existing wood poles within the project limits (Orange Street and Saxton Street).
- Street Tree planting, this will be done in some areas within the project limits (Orange Street and Saxton Street). Additional information was provided in the meeting presentation available in the project webpage.
- Street Tree removal, will be done in some areas within the project limits (Orange Street and Saxton Street), additional information was provided in the meeting presentation available in the project webpage.

Utility Work:

- Water Bureau lead water service replacements completed in 2019.
- Water Bureau water valve replacements and adjustments to be completed during the street construction.

- RGE (Electric) some underground electric conduits will be lowered at curb cuts.
- RGE (Gas) some underground gas services will be lowered at curb cuts.
- Frontier some wood poles will be replaced and relocated.
- Other Utilities relocate overhead wires.
- Utility Appurtenances adjust to grade with concrete collar.

Construction Work Zone Traffic Control:

- Construction anticipated to last 5-6 months.
- Two-way traffic will be maintained using flaggers and daily lane closures when necessary.
- Some temporary disruptions during curb and sidewalk replacement at driveways.
- Emergency access will be maintained during construction.

At the end of the project slide presentation, there were the following questions from one of the attendees Mr. Scott Benjamin.

- Question: is the presentation will be available in the City webpage? Response, it will be available in the project webpage later this week.
- Question: Existing street width will be modified on Orange Street and Saxton Street? Response, street width on Orange Street and Saxton Street will remain as existing.
- Question: what other driveways will be closed off? Response, each property owner will receive a
 driveway notification letter from Permit and Zoning department with instructions to legalize their
 driveways only for illegal driveways. Javier Vargas, will send an e-mail to Scott Benjamin with a
 list of properties with illegal driveways to follow up with each resident.
- Question: will any work to be done on the old sewer main on Saxton Street? Response, some
 catch basins will be replaced, during construction the sewer will be cleaned, and repaired as
 needed. Dominic Fekete, told Javier Vargas to follow up with Monroe County Pure Waters to
 confirm if the County did investigate the sewer main and made some repairs and if they televised
 the main at some point.
- Question: any speed bumps along Saxton Street? Response, was no, Javier Vargas explained to Scott Benjamin the process the City follows for the installation of speed humps. Dominic Fekete added to provide Mr. Benjamin the speed hump policy.
- No more questions from any panelists or attendees

At the end of the meeting, Javier Vargas stated that the public could visit the City Project website to review project materials and encouraged the public to contact him directly by phone or e-mail to ask questions. The meeting was adjourned at approximately 6:15 p.m.
